- **Cancellation Charges:** Customer agrees that at a minimum they will pay for the following costs:
 - Order cancellation prior to 30 days after KTX receipt of customer order, the customer will be charged 50% of the dedicated molds and (if applicable) all equipment prices herein stated.
 - Order cancellation between 30-60 days after KTX receipt of customer order, the customer will be charged 90% of the dedicated molds and (if applicable) all equipment prices herein stated.
 - Order cancellation after 60 days after KTX receipt of customer order, the customer will be charged 100% of the dedicated molds and (if applicable) all equipment prices herein stated.
- Mass Production Program cancellation, when dedicated charges are amortized in part price over the period of time or quantities herein qualified, whichever comes first – customer pays all reasonable time (charged at €125/hour) and materials (charged at cost +15%) costs involved as well as all unrecoverable capital costs.
